PROJECTS AND ACTIVITIES UPDATE

O-TTPS Update Project

The Open Trusted Technology Provider™ Standard (O-TTPS) Project made progress on its planned goals and deliverables.

- The O-TTPS Update Project successfully published The Open Group Guide: Open Trusted Technology Provider Framework (O-TTP) in September 2021. This document describes the vendor and technologyneutral framework; an evolving compendium of organizational guidelines and best practices relating to the integrity of Commercial Off-the-Shelf (COTS) Information and Communication Technology (ICT) products and the security of their supply chains throughout the entire product lifecycle. This document is intended to specify the formal taxonomy and terminology of the Open Trusted Technology Provider Standard (O-TTPS).
- The O-TTPS Update Project Team distilled the learnings from the design-thinking workshops held
 earlier in the year with organizations with an O-TTPS Certification and with O-TTPS Recognized
 Assessors. The Project Team was able to identify areas of the O-TTPS to strengthen and enhance as
 well as areas that have reduced in relevance over the years, ensuring the standard addresses supply
 chain threats and changes in threat vectors.
- The O-TTPS Update Project Team began revising the Open Trusted Technology Provider™ Standard (O-TTPS), Parts 1 and 2, altering the original goal of bringing it to Version 2.0 and instead deciding to update the O-TTPS to Version 1.2. The Project Team determined that updates required to the requirements and evidence were insufficient to justify a completely new version. Updates include a complete review of every "should" requirement and debate over whether they ought to become "shall" requirements; for those that became "shall" requirements, the Project Team debated and determined appropriate Evidence of Conformance, whether Process Evidence, Implementation Evidence, or both. The O-TTPS, Parts 1 and 2 are expected to enter Forum Review in 4Q2021.

Forum Content Update Project

The Forum Content Update Project was formally concluded in 3Q2021, with Members determining that maintenance updates of online OTTF content would become a task of the OTTF Steering Committee.

- The Forum Content Update Project Team created and published several videos:
 - Forum Director John Linford developed a video providing the context and an overview of the Open Trusted Technology Forum. This video describes the origins of the OTTF and its current goals
 - Andras Szakal, The Open Group CTO, created a video on the O-TTPS Certification Program.
 This video provides an overview of the certification process
- The Forum Content Update Project Team updated and published the OTTF Data Sheet to better reflect current activities and goals of the Forum
